There are no spaces for children to participate.

They do comply when they build parks, the roads are very damaged, but they do them badly.

The government committed itself to everything and it has to comply with those of us who live in distant towns and not only in Bogotá and Cali.

For example: If there is no compliance in education, what happens to the young people when they graduate from high school? What opportunities do they have? What is the point of graduating?

In our municipality education is not very decent, we are receiving classes and there are bullets that go through the classroom.

Prevention and attention to sexual violence against children and adolescents.

Protected participation of children and adolescents:

Child labour

They make the decision to join an armed group because they think they can get money, power and respect by getting a gun.

The young men like to go out and drink, they give them gifts such as alcohol and other things, but then they collect the debt from them and they can take it away.

To show off, sometimes they are not part of the group, but on social networks they use accessories to make themselves feel part of the group (Illegal Armed Group).

Now it has become fashionable for young people to join these groups. There are around 20 recruits in community x and around 5 in community y.

It can be seen that the illegal armed groups have a new strategy with the educational institutions, they make a kind of characterisation of the different leaders in the school, because the girls are attracted to those who get involved with these groups. The girls become informants and that puts them in danger.

The girls get involved with these young people.

We don't know if they are there because they want to be or because of threats, one girl was threatened that her family would be affected and she did it to save her family, nobody knows what happens internally to those who leave.

Ensure that child and adolescent victims of the armed conflict are prioritized with a view to restoring and rehabilitating their rights, in particular to family reunification, health, education and psychosocial care, taking into account the Victims Act.

Strive to end the recruitment of children and adolescents by armed groups.

Investigate all cases of illegal recruitment of children and adolescents into armed groups and bring the recruiters to justice.

Provide support to girls and young people who have been demobilized, regardless of the illegal armed group to which they belonged.

Observation: Young people in their urban context do not perceive the plots and dramas of children and adolescents in the conflict. This is done as a group contextualisation team. As a result, young people are worried about what will happen when they leave the conflict.

Ensure the recovery, rehabilitation and reintegration of children and young people who have been involved in war.

Demobilize child combatants.

Ensure that children and adolescents who have been victims of armed conflict are prioritised in order to restore and rehabilitate their rights, in particular to family reunification, health, education and psychosocial care, taking into account the law on victims.

Make efforts to put an end to the recruitment of children and adolescents by armed groups.

Provide assistance to children and adolescents who have demobilised, regardless of the illegal armed group to which they belonged.

Investigate all cases of illegal recruitment of children and adolescents into armed groups and bring recruiters to justice.

Demobilise child and adolescent combatants.

Ensure the recovery, rehabilitation and reintegration of children and adolescents who have been involved in war. Ensure the presence of human rights organisations in the territory.

Carry out workshops for children to prevent them from joining armed groups.

Work with children who have joined armed groups and with those who have not on the fact that these groups disharmonise the territory.

Improve security in our territory and in schools so that there is no more recruitment of minors and that they do not harm our children.

Where my sister lives a bomb exploded. That's why they gave us a talk in our school about how to be careful with landmines.

In the community XX and in the community YY, what happens is not all the government's fault, but part of it is, because they put the army and the illegal armed groups together, some above and some below. In XX place there are both legal and illegal armies, they know that some are up the hill and some down the hill, and people are always in the middle because of the confrontations.

Although the girls consider this to be one of the most important rights for creating safe spaces, there is a lack of knowledge about the ways and mechanisms for protection and safety in this type of situation.

The children do not give any further information on this issue, saying that there may be cases but that they are not aware of them.

Strengthen programs for the prevention of tramcking in human beings, especially for children and adolescents from the most disadventaged groups and communities, as foreseen in the National Strategic Plan.

No girl considers the previous recommendations irrelevant in this case.

Comments: They provide a paradise for girls and teens in exchange for showing their body parts.

Recommendation: One girl recommends that there should be more discipline on this issue and that it should be instilled in the police.

The girls recognize the impact of risks related to social violence against them and also emphasize the importance of protecting their rights in order to create a more egalitarian society.

Regarding this issue, the girls reported that cases do occur, but nobody talks about it.

Adopt all necessary measures to ensure the full protection and enjoyment of all rights of children and adolescents in Colombia.

Improve protection, including investigation, prosecution and prevention of violence against children and adolescents. Strengthen efforts to prevent sexual violence against girls, boys and women, and strengthen measures for the rehabilitation of those affected by such acts as a result of the armed conflict.

Apply the laws, decrees and resolutions adopted to combat violence against women and girls and ensure access to justice for victims of sexual violence.

People are given 15 days to stay or leave.

Some leave voluntarily and are not taken away by force.

Some like the easy work, they think a gun can create fear and power.

They join to gain respect, they take pictures of themselves with guns so that they can be seen.

Sometimes children are used as informers.

We think that in some places where we are, there might be informers and we don't know that there are.

Where I study, all those who finished eleventh grade went there (to the GAI).

Most of them are men of different ages who join these groups, as well as teenage girls and young women.

Ensure that child and adolescent victims of armed conflict are prioritised with a view to restoring and rehabilitating their rights, in particular to family reunification, health, education and psychosocial care, taking into account the Victims Act.

Make efforts to end the recruitment of children and adolescents by armed groups.

The methodology resulted in an omission in the selection of 3 statements:

Provide assistance to girls and adolescents who have demobilised independently of the illegal armed group to which they belonged.

Ensure the recovery, rehabilitation and reintegration of child and adolescent combatants.

Observation: Young people in their urban context do not perceive the plots and dramas of children and adolescents in the conflict. This is done as a group contextualisation team. Afterwards, the young people express their concerns about what will happen after the people leave the conflict.

That there should be more security in the areas so that children are not recruited.

There should be more monitoring on families to prevent their children from being recruited. Hold workshops for children, adolescents and young people to prevent recruitment.

Have an ethnic guard to protect children from recruitment.

Hold workshops with families to prevent recruitment.

They put 5 mines on the side of the road, they put them under the garbage so they would not be detected, my mother wanted to burn the garbage but luckily she saw them and managed to deactivate them.

Parents should teach children to be careful, they like the bush and we go and walk in our farm and sometimes they put these mines there.

We say they are bad but we never ask them why they are doing that, why they are going against the government when the government has corrupt people.

Recommendation: Make society more aware of the risks of trafficking in women, girls and adolescents.
